### Trash Storage Requirements Reminder

Since Republic Services made the change to provide trash and recycling bins to the community with oncea-week pickup, trash storage violations have been observed frequently. By this time, Republic Services should have been able to fulfill all requests for trash container exchanges to switch from the larger size to the smaller size, as needed and dispose of old bins. With the "newness" of the new trash pickup procedure wearing off, the Association wishes to remind everyone of the community's requirements.



- The trash containers must STILL BE STORED OUT OF **SIGHT!** They may not be stored on the side of the home or in any other location that is visible from the street.
- Trash and recycling is now picked up **once per week—ON** TUESDAYS.
- Trash containers should not be placed out before Monday and should be removed from the curb Tuesday night.

CC&Rs Section 9.15 Unsightly Articles: ...Refuse, garbage and trash shall be kept at all times in covered, sanitary containers, or enclosed areas designed for such purpose. Such containers shall be exposed to the view of neighboring Units only when set out for a reasonable period of time (not to exceed twelve (12) hours before scheduled trash collection and twelve (12) hours after scheduled trash collection hours...
